If the landlord and tenant terminate the contract with agreement, with mutual consent between the parties, the necessary modification of the lease agreement is registered with the relevant authority, the amendment is made at the request of that authority. In addition to the rental photo affixed to the agreement, the contract is signed by at least two witnesses on each side. A copy of the contract is kept by the landlord and tenant. After mandating the following events, a tenant may leave the rented house before the tenancy period expires and notify the landlord in writing in advance of at least thirty-five days; Under no circumstances can the tenant demolish, remove or modify the structure of the building without the landlord's consent and thus causes damage to the owner. of the house, the landlord has the right to claim damages from the tenant. If a tenant disappears without paying rent for 3 months or more without notice and there is no idea of its location, the landlord must evacuate the house after the request to the competent municipal office at the local level. . In the event of termination of the tenancy agreement, it is the obligation for the tenant to return these properties in good condition. A tenant who rents a home for commercial or industrial purposes. However, if the person who is obliged does not purchase the insurance of the house, and the house is damaged by a cause such as disaster, riot, fire or other similar reasons, the tenant is responsible for the payment taking into account such damage.
